LEGISLATIVE UPDATE

There is a lot going on since the passage of Act 144, and the Board of Architecture is currently planning to break the new regulations up into 3 packages:

- 1. The first draft package will be available later this month and regulates the CEUs that are now required for registration.
- 2. The next package will initiate the registration process for CIDs and set up associated fees and requirements.
- 3. The last package will spell out how CIDs use their certification and which documents should be signed with their CID #.

There will be public comment periods for each regulation package when released prior to adoption, make sure you are receiving our emails and we will keep you up to date as they are released. If you haven't already, check out our YouTube channel where we're post the Town Hall. Currently, its in 4 parts but we are planning to post a non-segmented video as soon as our time limit restrictions are lifted.

LETTERS TO EMERGING DESIGNERS BY MISS KIMBERLY

Dear Miss Kimberly,

I'm finding it challenging to understand what advice is best to take as I move forward in my interior design career. Some of the advice I've received recently has conflicted with other guidance. How do I know which advice to take?

- Stuck on Decisions

Dear Stuck on Decisions.

I'm so glad you brought this question forward. It's something I've spent time asking myself as well, and over the years, I've come to an understanding: not all advice is equal. And that is perfectly okay.

The best way to distinguish between "good" advice and guidance that may not serve you is to consider two things:

- Is the advice specific to your needs? Does it speak to you, your goals, your stage, and your vision for your career?
- Who is giving the advice? Ideally, they are living the life and career you aspire to or have current, firsthand knowledge of that path.

Advice from someone who hasn't walked the steps you're trying to take is best taken with a grain of salt. Those in your niche, people who have done what you are doing or are moving in that direction, often provide the most relevant guidance.

It also helps to pause and understand yourself—your goals, your priorities, and what you truly want in your career and life. There are so many ways to navigate the interior design industry.

And that is why I say this so plainly: Decision fatigue is real.

Decision-making in design careers can feel overwhelming: Who should I work for? Which part of the industry should I focus on? When should I take the NCIDQ exams? How should I prepare? Should I take them in stages or all at once? Should I go back to school? Should I network more? Should I join organizations in the industry?

These questions are valid. And at the end of the day, there will always be decisions to make. That is inevitable. The key is to use your understanding of yourself to guide those choices. Once you do, recognizing helpful advice becomes easier, and your decisions will come with confidence and strength over time.

Career growth isn't a straight path, but thoughtful understanding and intentional choices make the journey meaningful and manageable.
